Part 1: Information about the pupil population

Number of pupils on roll at the school: registered for 68

Information on pupils by protected characteristics

The Equality Act protects people from discrimination on the basis of 'protected characteristics'. Every person has several of the protected characteristics, so the Act protects everyone against unfair treatment.

In order to ensure that all pupils are protected from discrimination, the school collects information on some protected characteristics of their pupils these include:

Disability*
Ethnicity and Race
Gender
Religion and Belief

* The Equality Act defines disability as when a person has a 'physical or mental impairment which has a substantial and long term adverse effect on that person's ability to carry out normal day to day activities.'

Sensitive information on some pupils with protected characteristics

It is not appropriate for us to collect information from pupils in relation to some protected characteristics, gender identity and sexual orientation.

However, as a school we are aware that there may be a number of equality issues for gay, lesbian and bisexual pupils, as well as those who are undergoing or who have undergone a reassignment of their gender.

Maternity and pregnancy is also a protected characteristic.

Where there are students who are pregnant or have young children, we will offer support to enable equality of opportunity.

Information on other groups of pupils

What has been the impact of our activities? What do we plan to do next?

Vulnerable groups:

- Data validates that PP students attendance is higher than non PP students (2019/20)
- 100% of Key Stage 4 LAC students will achieve at least 5 qualifications. (2019/20)
- Use of PP funding to increase wellbeing and resilience for all students especially those with SEMH needs.

Part 3: Consultation and engagement

We aim to engage with and consult with pupils, staff, parents and carers, the local community so we can improve our information, learn about the impact of our policies, develop our equality objectives and improve what we do.

Our main activities for consulting and engaging are:

- We formally consult with parents on a variety of issues (including any bullying and harassment) on an annual basis
- Informal consultation with parents takes place very regularly. Our level of contact will be greater if there are difficulties which need to be addressed
- Each pupil has a tutor. The tutor meets daily with the pupil to look at targets for achievement and behaviour and to address any difficulties the pupil may be experiencing

Progress we are making on this objective:

Bullying is rare

Records show that there are few incidents of bullying and where they occur this is short-lived and limited to name calling. The children tell us that are not fearful of any bullying. There are a range of adults within the Learning Centre who children feel very confident in approaching for support knowing their views will be listened to with concern and respect. A new bullying policy and procedure has been produced.

Pupils, parents and carers tell us that behaviour is good and the children are safe

Regular surveys and discussions are used to monitor views. The overwhelming majority of parents and children consistently tell us that the children like Learning Centre and feel secure in a caring environment.
